4. Finance

- a. **Review of the Current Income Statement** *President Chad Sanders & Treasurer Robert Tataryn are reviewing some expenses. Staff advises that there is nothing notable. The committee approves the income statement.*
- b. **GIC Investment** Staff & Treasurer Robert Tataryn met with the Credit Union regarding investing in a GIC, watching interest rates before investing, considering \$100,000.00 for a 5-year term. Staff to check financial policy for reserve amount before investing.

5. SGM/AGM

- a. **SGM** November 16, 2022 at 6:00 pm at Sport Manitoba. 12 voting members required to be present with 7 required to be board members. Staff amended everything with reference to "ABAM" to read Archery Manitoba. Second item amended was the "Interpretation" wording, any reference to gender was removed. Changes to bylaws in regard to Membership Categories (not shooting categories), amended to include "school registrants". Under "Meetings", initial notice deadline for AGM's, SGM's & to amend the bylaws was amended to 21 days from 15 days.
- b. AGM November 16, 2022 at 7:00 pm Hybrid meeting
- 6. Sanford Enhancement Grant President Chad Sanders & Treasurer Robert Tataryn met & discussed a plan for improvements at Sanford range, permanent accessible washrooms, new gravel on the driveway, new gravel on the target shooting line, the grant is \$25,000 with a \$38,000 input. Chad suggests establishing a committee, requests a motion to approve a subcommittee (3-4 people) for the purpose of the Sanford Enhancement Funds Allocation. If the grant is not approved, they will look at other options. There is an Accessibility Grant that is also to be considered. Motion by Mike Oneschuk, seconded by Kelly Taylor, Carried.
- 7. **World Police Fire Games** VP of Coaching/Officiating Mike Oneschuk provided an update in regard to number of target archers (120) to be accommodated, shooting a 900 round, require distances of 40m, 50m, 60m. 3D require distances of up to 70 80m, 23-28 targets on one course. Field 20 targets. Dates are July 28 August 6, 2023. Staff & Treasurer Robert Tataryn to discuss & assess a rental fee for the site & equipment. Mike to contact judges for availability.

8. Athlete Development

- a. Canada Winter Games Update Staff updates that committee that the trials underway & running smooth, looking for a venue for match play, considering Heartland or Heights, Saturdays or Sundays, 4 matches per day, 2 days.
- b. Staff reported that he is working with Saskatchewan to plan the pregame competition in Saskatoon, the venue is secured, dates confirmed, looking at travel costs, etc., expecting 40 60 athletes & staff.

Discussion with Staff & committee in regard to holding a "championship" tournament with medals, etc., for participants of the Yeoman Shoots.
